PUBLIC COMMENT – President Kisling asked if anyone from the public wished to comment. A. Hart requested to speak. He suggested reconsidering the District's spending on the lawsuit between Saucelito ID, and Friant. President Kisling asked if Andrew agreed with FWA's decision to place the entire cost on SID. Hart believed Friant might negotiate. President Kisling mentioned previous resistance from Friant in discussions. The Manager added that Jason Phillips rejected the idea of negotiating. Discussion ensued. President Kisling stated that if there are no further comments, we will move on to the monthly reports.

FINANCIAL—The Board reviewed the District's financial status. RESOLUTION NO. 2025-01

A RESOLUTION OF THE BOARD OF DIRECTORS ELECTING FOR SAUCELITO IRRIGATION DISTRICT TO SERVE AS A GROUNDWATER SUSTAINABILITY AGENCY PURSUANT TO THE SUSTAINABLE GROUNDWATER MANAGEMENT ACT

WHEREAS, the Sustainable Groundwater Management Act ("SGMA"), California Water Code section 10720 et seq., which was signed into law on September 16, 2014, requires that each California groundwater basin or subbasin be managed by a Groundwater Sustainability Agency ("GSA"), or multiple GSAs, and that such management be implemented pursuant to an approved Groundwater Sustainability Plan ("GSP") or multiple GSPs; and

WHEREAS, Saucelito Irrigation District ("SID") is a local agency as defined in Water Code Section 10721(n); and

WHEREAS, California Water Code Section 10723(a) authorizes any local agency overlying a groundwater subbasin to become a GSA for that basin; and

WHEREAS, SID's service area overlies the Tule Subbasin, as depicted by the map attached hereto as Exhibit A; and

WHEREAS, the public hearing was noticed in Visalia-Times Delta on January 23, 2025 and January 30, 2025, pursuant to Water Code Section 10723(b) and Government Code Section 6066; and

WHEREAS, SID held a public hearing on February 13, 2025, to consider forming a GSA; and WHEREAS, after considering the GSA formation and hearing public testimony, the Board determined that it is in the best interest of SID, its landowners, and water users to serve as the GSA of the subbasin underlying its boundaries.

NOW THEREFORE, BE IT RESOLVED:

- 1. SID elects to serve as the GSA of portions of the Tule Subbasin as depicted by the map attached hereto as Exhibit A, including future revisions approved by SID and the California Department of Water Resources, if any.
- 2. Within thirty (30) days of the effective date of this Resolution, the General Manager shall submit a notice of intent to the California Department of Water Resources, pursuant to Water Code Section 10723.8(a), and complete all necessary tasks related to this matter.
- 3. The General Manager shall, after complying with Water Code Section 10723.8, begin developing a GSP for the GSA;
- 4. The General Manager shall maintain a list of interested parties regarding the newly formed

GSA pursuant to Water Code Section 10723.4.

AUTHORIZING EXECUTION OF CONTRACT(S) FOR PURCHASE OF UNRELEASED RESTORATION FLOWS BETWEEN UNITED STATES AND SAUCELITO IRRIGATION DISTRICT

WHEREAS, pursuant to the Stipulation of Settlement in *Natural Resources Defense Council, et. al.*, v. Kirk Rodgers, et. al., hereinafter referred to as Settlement, and the SJRRSA, the Secretary of the Interior, acting through the Bureau of Reclamation, hereinafter referred to as Contracting Officer, is directed to implement a program that releases Restoration Flows from Friant Dam; and

WHEREAS, consistent with Paragraph 13(i) of the Settlement, if, for any reason, full Restoration Flows are not released in any year beginning January 1, 2014, the Contracting Officer shall release as much of the Restoration Flows as possible, in consultation with the Restoration Administrator, in light of then-existing channel capacity and without delaying completion of the Phase 1 improvements; and

WHEREAS, the Contracting Officer, in consultation with the Restoration Administrator, shall use the amount of the Restoration Flows not released in any such year, hereinafter referred to as Unreleased Restoration Flows or URFs, by taking one or more of the steps prescribed in Paragraph 13(i) of the Settlement to best achieve the Restoration Goal, as determined by the Contracting Officer; and

WHEREAS, the District and the United States have entered into Contract No. 16-WC-20-4876, hereinafter referred to as Contract, for the delivery of Project Water; and

WHEREAS, the Contracting Officer has determined that it shall make available for delivery to the District URF's, as Project Water, pursuant to Article 3(f) of the Contract; and

WHEREAS, the Board of Directors has determined that it is the best interests of the District and its landowners that the District purchase and ensure delivery of all water available to the District pursuant to the terms of that certain contract entitled "Agreement Between The United States And Saucelito Irrigation District For Sale of Unreleased Restoration Flows".

NOW, THEREFORE BE IT RESOLVED by the Board of Directors as follows:

1. The foregoing recitals are true and correct.

2. The President and Secretary are authorized to execute that certain contract entitled "Agreement Between The United States And Saucelito Irrigation District For Sale of Unreleased Restoration Flows" on behalf of the District subject to review by District Counsel.
