PUBLIC COMMENT – President Kisling asked if anyone from the public wished to comment. Andrew Hart spoke for Booth Ranches. Andrew asked about the District's letter that was sent to the ETGSA giving up any future Tier 1 transitional pumping. Discussion ensued.

MONTHLY REPORTS

FINANCIAL—The Board reviewed the District's financial status. Included in the review were the Citizens Business Bank accounts check register from the prior month, Local Agencies Investment Fund reports, Money Market Account Statement, Treasurer, Collector's, and Secretary's reports, and Income and Balance Sheets. Discussion ensued.

OPERATIONS & WATER

The Manager reported to the board that water usage in September amounted to 2694 acre-feet. Dennis Keller provided an overview of storage levels in Millerton, including SCE operations and releases. It was noted that San Luis Reservoir is expected to provide 80,000 acre-feet from the drought pool to meet the needs of the Exchange Contractors. Discussion ensued. The board packet includes the Employee Safety Meeting report and the Monthly Field Staff Report for the Board's review.

STATUS OF AUTHORITIES – The Manager continued forwarding CEO updates from Jason Phillips, CEO of FWA when available, and the AECA newsletter to the Board members. The Manager reported that Nick Keller continues to work on the pumping stations and has bi-weekly meetings to discuss the pumping plants' design. Discussion ensued.

EASTERN TULE GSA—The Manager reported that the State Water Board is sending letters to growers with wells in the Tule Sub-basin, which is on probation. Dennis Keller spoke for the District at the hearing and is working to remove the District from probation. Keller noted that two other districts were not put on probation and aims to exempt Saucelito from fees and reporting requirements. The first step is to avoid adding more transitional pumping to growers' accounts with ETGSA. President Kisling stressed keeping options open for stability. Keller acknowledged the need for swift action to achieve the same status. Discussion ensued.

2024-2025 WATER YEAR – WATER POLICY – There is nothing to report today.

EIR Study for Groundwater Banking Policy Program

The Manager reported that he is meeting with P&P every two weeks throughout the process. He also mentioned that he and the staff have met with Kern-Tulare WD personnel to gather more information about their well monitoring program. They have agreed to share their documentation, and the field staff have been locating the wells within the District. Discussion ensued.
